MEMBERSHIP PROMOTION

The persistent, uninvited guest in the room at Committee meetings has been the slow decline in Club membership. In addition to the pandemic factor, our Club members have been aging, with the average member now well into their 80s, some have been forced due to ill health, relocation, and other factors to withdraw or be placed on the Non-Active Member list. Membership growth has therefore been a priority for the Committee through 2023/24.

To attract new members, the Committee has initiated several marketing initiatives. Committee member John Elvy has been most active in this area and through his efforts we have moved into the tricky world of electronic marketing and social media. The Club is now attracting followers to its own Facebook page and also now features prominently on the daily marketing screens throughout the Mittagong RSL Club. To maintain the momentum, a new Committee Portfolio of Club Marketing and Social Media Coordinator with responsibility for curation of the Facebook Page and oversight of other electronic promotion initiatives has been created.

CLUB SPEAKERS

Ably managed by Geoff MacBean, over the past 12 months every General Meeting has enjoyed presentations by both our treasured member speakers and an array of fascinating guest presenters. With each speaker booking requiring many emails and phone calls Geoff, who is an experienced speaker 'sleuth' of many years' experience, during 2023/4 organised a total of 22 speakers. Too numerous to cite here, the monthly presentations remain a key club activity which members look forward to each month. Our sincere gratitude is extended to Geoff for his management of this demanding area.

FINANCIAL

The Club's financial assets were in a healthy state at 1 March 2024 with total funds of \$6830.13 at hand.

Changes to Member Financial Interactions with the Club

(The following is part of a statement which was read and tabled at the General Meeting held on 11/5/23 to clarify Committee decisions regarding changes to the future of the Club's financial interactions with members).

1. General Meeting tea and coffee cash payments

- For 2023/24 cash payments for tea/coffee will continue to be accepted at each monthly meeting at the welcome desk in the usual time-honoured way.
- Members are encouraged to pay for their annual tea/coffee in advance. This advance payment can still be made in cash at the desk but preferably by EFT to the club account
- From April 2024 the annual membership fee of \$40 (which has remained unchanged since 2011) will continue unchanged but a Tea/Coffee fee of \$30 will be charged.
- This combined amount can still be paid in the usual way my members, but the Club's preferred option is for payment by EFT

- From April 2024 monthly cash payments for tea/coffee will no longer be accepted at the welcome desk.
- The Committee acknowledges our special members and guests and so the tea/coffee fee will not apply to Life Members, Non-Active Members or any guests attending General Meetings. These will be the guests of the Club at the fellowship break.

2. All other financial interactions

• The method of payment will remain the same for membership fees, tours, dinners etc but with the understanding that the Club's strongly preferred option is payment by EFT.

GOVERNANCE AND WELFARE

The less visible areas of Committee responsibility include maintaining social connections with members who may be experiencing some life challenges. Malcolm Stevens has made regular contact with members who may have been experiencing difficulties. He has brought both sensitivity and care to this important area. Jim McGrath with his eye for administrative detail has managed our governance matters including relations with PSPL our parent organisation and I thank him for this.
